RESOLUTION NO. 02-2016

In Support of the Live Well San Diego Partnership

WHEREAS, CILS fulfills the Live Well San Diego partner requirements by supporting positive choices and improving the culture within.

WHEREAS, CILS is committed to continuing to advance Live Well San Diego into the future, and is embracing strategies of this initiative in ways illustrated here:


- Improving the culture by supporting positive change by increasing understanding of Native Americans and how to assist them in increasing their quality of life.
- Supporting positive change by providing information and resources to inspire Native Americans to take action and responsibility for their health, safety, and well-being.
- Building a better service delivery system by sharing knowledge and resources with Live Well partners to increase understanding and services to Indian communities resulting in better outcomes for Native Americans and the communities they live in.


NOW, THEREFORE, BE IT RESOLVED that the CILS Board of Trustees hereby approves the partnership with the County of San Diego's Live Well San Diego Initiative during the meeting occurring on Saturday, June 4th, 2016.
