*WHEREAS, the San Diego Futures Foundation has implemented innovative programs that understand and address the needs of seniors, youth, and people in low-income households; and*

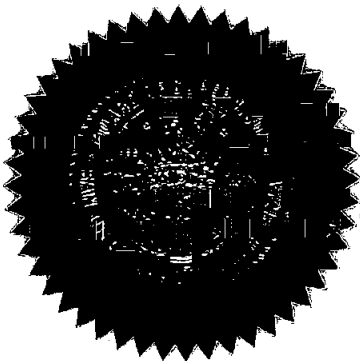
