# H.R. 1 Background

# Timeline of Changes



On July 4, 2025, H.R. 1 was signed into federal law. The bill included changes to the CalFresh and Medi-Cal programs, including but not limited to:

Implementation Date	Policy Change	Estimated San Diego County Impact*
January 1, 2026	Full-scope Medi-Cal enrollment freeze for individuals with “Unsatisfactory Immigration Status” (UIS)	Applies to new applicants only
April 1, 2026	CalFresh non-citizen eligibility categories will change	13,000 customers
June 1, 2026	CalFresh Work Requirements will apply to “Able-Bodied Adults Without Dependents” (ABAWD)	93,500 customers
October 1, 2026	The federal government will change how some immigration statuses are classified for federally funded full scope Medi-Cal benefits	75,000 customers with UIS
January 1, 2027	Medi-Cal Work Requirements begin	314,000 customers
January 1, 2027	Medi-Cal six-month eligibility checks begin	130,000 customers

# H.R. 1 Background




H.R. 1 includes two CalFresh changes that California must implement in 2026:

1. Changes to eligibility for some non-citizens
2. Reimplementation of the Able-Bodied Adults Without Dependents (ABAWDs) time limit





# CalFresh: Eligibility Changes For Non-citizen Individuals



***Implementation Begins April 1, 2026***

# CalFresh: Non-Citizen Eligibility



Effective **April 1, 2026**, California will implement changes to non-citizen eligibility:

- **New CalFresh applications** received on or after April 1, 2026, will be reviewed using the new rules.
- Starting April 1, 2026, **households already receiving CalFresh** will be reviewed using the new rules at their next annual renewal.



# Who is Still Eligible for CalFresh?



Starting **April 1, 2026**, customers **are eligible** for CalFresh if they are one of the following:

Lawful  
Permanent  
Resident (LPR)

Cuban or  
Haitian Entrant  
(CHE)

Compacts of  
Free  
Association  
(COFA) citizen

# Who is No Longer Eligible for CalFresh?



Starting April 1, 2026, customers are **no longer eligible** for CalFresh if they are a/an:

Asylee

Refugee

Parolee  
(unless CHE)

# CalFresh Non-Citizen Eligibility




- Ineligible non-citizens who **adjust to a qualifying immigration status** *may* be eligible for CalFresh.
- For example, a refugee adjusts their immigration status to Lawful Permanent Resident (LPR).



# CalFresh: Work Requirements

For Able-Bodied Adults Without Dependents (ABAWDs)



***Implementation Begins June 1, 2026***

# CalFresh: ABAWD Work Requirements

**Effective June 1, 2026:**

**ABAWDs will have to meet CalFresh work or volunteer requirements, or qualify for an exemption, to have continuous CalFresh benefits.**

**New CalFresh applications will be reviewed using the new rules.**

**Households already receiving CalFresh will be reviewed using the new rules at their next annual renewal.**



# CalFresh: ABAWD Work Requirements



**Starting June 1, 2026 people who must meet work requirements include:**

- Adults 18-64
- Do not have children under 14 at home
- Are physically and mentally able to work
- Do not meet any other [exemptions](#)

**Work requirements can be met by completing 20 hours/week or 80 hours/month through the following activities:**

Work

Self-  
Employment

Training

Volunteering

# Exemptions

The new work rules do not apply if you are:



Under age 18 or over 64

Parent of/responsible for a dependent under age 14

Physically or mentally unfit for employment

Pregnant

Identify as Indian, Urban Indian, or California Indian under the Indian Health Care Improvement Act (IHCA)

Qualify as excused from the CalFresh work registration requirements:

- Caring for a person w/a disability
- Receiving or applying for unemployment benefits
- Receiving or applying for disability benefits
- Disabled
- Attending school, college, or a training program at least half time
- Meeting the work requirement for CalWORKs
- In a drug or alcohol abuse treatment program



